## Implementing the Pigeon Lake Watershed Management Plan

The mission of the Pigeon Lake Watershed Association (PLWA) is to *enhance, preserve and protect Pigeon Lake and its watershed as a healthy and environmentally sustainable ecosystem for current and future generations.* The organization plays a lead role in facilitating community action, advocacy and education, supports policy changes to promote beneficial land use management practices, and partners with the GOA, non-profits and the universities to invest in initiatives and research for the lake. Our work benefits Pigeon Lake. In turn, a healthy lake supports recreation opportunities and the economic viability of the region to benefit all communities in the watershed.

## **Resources and funding for Pigeon Lake**

It is an ongoing challenge to find sustainable funding to support the organization and the PLWA programs. In 2021, our work to protect the Lake was made possible by generous donations from individuals and families in the community, sales and fundraising events, grants from the Government of Alberta, Government of Canada, Alberta Real Estate Foundation, Edmonton Community Foundation, and Alberta Community Partnership (administered through of the Summer Village of Grandview). ### **PLAN OBJECTIVES**

Watershed Stewardship Advocacy & Education Encourage landowners to adopt proactive lake-friendly environmental management practices, landscaping and activities.

Clean Runoff: Promote clean runoff practices on private and public properties as per the Alberta Clean Runoff Action Guide

Shoreline Practices and Restoration: Provide guidance documents, technical information, and support to shoreline landowners to implement healthy shoreline practices, shoreline restoration, and lake-friendly landscaping.

Continue noxious weed and invasive species eradication programs

Invasive Species: Complement the Government of Alberta's province-wide efforts with local initiatives to improve education and build local defenses to keep out aquatic invasive species. Measures include monitoring, public education, signage, and other initiatives

Improve regional collaboration, partnerships and organizational effectiveness to promote collective action.



### **ADVOCACY**

A proposed Village West Area Structure Plan was circulated in December 2021. PLWA reviewed the proposal, environmental policy, and comments from municipalities. PLWA believes the environmental effects are not fully assessed nor is the development proposal balanced

in terms of economic versus environmental quality trade-offs. The PLWA outlines the environmental significance of the area and formally appeals to the proponent to address how this development will avoid harming the lake.

### **STEWARDSHIP**

In 2021, PLWA kicked off the Clean Runoff Property Assessment Program. Residents met with PLWA staff and a Landscape Architect from McElhanney to assess opportunities to better slow and filter stormwater runoff from their property. Participating residents received clean runoff landscape plans along with a Plant Resource Guide. A landscape plan was also completed for a new clean runoff garden in Mulhurst Bay.

Caring for the Lake Together branding and stewardship resources were added to the PLWA website. Branded window stickers are now featured in storefronts around Pigeon Lake including a QR Code to direct people to resources on the website. A *Caring for the Lake Together* social marketing campaign, on twitter, Instagram and Facebook, reached 57,000 (including a reach of 3200 weekly on Facebook). PLWA members also received stewardship information twice a month from May to September and updates were shared through the municipalities. PLWA conducted webinars on alternative farm programs, land conservation, clean runoff, shoreline and riparian health, native plants, and best practices for living with beavers. ## **PLWA Supporting Engagement & Resource Development**

PLWA provided feedback during public meetings as municipalities revised land use bylaws and drafted intermunicipal land use plans. Thank you to the municipalities for their ongoing commitment to including enhanced environmental protections and policies from the Pigeon Lake Watershed Management Plan and Model Land Use Bylaw in statutory plans. The North Pigeon Lake Intermunicipal Development Plan between Wetaskiwin County, Silver Beach, Argentia Beach, and Golden Days was approved in 2021. And, there was significant progress towards approving the South Pigeon Lake Intermunicipal Development Plan between County of Wetaskiwin and the Summer Villages of Crystal Springs, Grandview, Norris Beach and Poplar Bay.



## Science & Technical Recommendations in the Pigeon Lake Watershed Management Plan

Lead Roles: PLWMP Steering Committee, Municipal, and Government of Alberta

Advancement of Science: Identify knowledge gaps relating to the formation of cyanobacteria blooms and techniques for meaningful reductions. Prioritize specific investigations and research projects. Source funds and implement ongoing research for Pigeon Lake.



Research and monitoring were the focus of the Pigeon Lake Leaders' Session in 2021 cohosted by PLWA and the Alliance of Pigeon Lake Municipalities. Presentations included remote sensing data from the Alberta Biodiversity Monitoring Institute and Vinebrooke Labs, LakeWatch monitoring was presented by Alberta Lake Management Society and the information about the newly purchased monitoring buoy was presented by Alberta Environment and Parks.

Special acknowledgement to the Summer Village of Crystal Springs and the In-Lake technical Committee for funding the purchase of the Monitoring Buoy, which provides an array of new data in a real time manner. AEP has now compiled a summary of the data from the Buoy after one season in the lake.

#### **CITIZEN SCIENCE PROGRAMS**

- 17 residents volunteered at Pigeon Lake as Citizen Science monitors. The monitoring programs included:
- The Alberta Lake Management Society, LakeWatch Zebra and Quagga Mussel Monitoring
- The Alberta Lake Management Society, Winter LakeKeeper, water quality sampling
- Spring freshet sampling of creeks and outfalls
- Core sediment sampling
