

# AGM Meeting Record - PIGEON LAKE WATERSHED ASSOCIATION (PLWA)

July 25, 2020, 9:30 am

Due to the COVID-19 pandemic, the 2020 meeting was hosted online.

Meeting started at 9:35 am with 16 members (list of participants included below)

Welcome and Land Acknowledgement – Wayne Buskas, PLWA President

Everyone was welcomed to the meeting on behalf of the PLWA Board of Directors and thanked for attending. It was explained that typically, the AGM and open house are our primary forum to gather, to discuss the state of the lake, and to hear from healthy-lake experts. Because of the COVID-19 pandemic physical distancing requirements and meeting limitations, the PLWA Directors felt that an online meeting was the best way to carry out this year's meeting and ensure the safety of our members.

It was confirmed that the AGM today will be a business meeting, approximately 50-60 minutes, with an opportunity for questions at the end. To hear from healthy-lake experts, members were encouraged to join in the regular online coffee conversations.

President gave the following land acknowledgement:

# **Business Meeting**

Meeting was called to order by Wayne Buskas, President.

# 3. PLWA & PLWMP Report for Members – Catherine Peirce, Executive Director

PLWA (and PLWMP) Report for Members - Catherine Peirce, Executive Director

PLWA has 1100 members in 2020, eight board members, one full-time staff, three seasonal staff and many volunteers.

- Water Levels fact sheet and weird fact sheet was presented.
- Addressing recent bloom dispelling myths e.g. providing information about health risks.
- Filling the Gaps Monitoring for algae, enterococcus and invasive species through the citizen science program. Also participating in eDNA sampling to fill in the data gap left by a decrease in AHS sampling.
- Enhanced Monitoring. New partnership with Vinebrooke Labs, UofA, ALMS to use satellite imagery and in-lake sampling to better understand the lake, first in Alberta. With seven other lakes it shows that there is more to know.
- Implementing the Plan. A review of our current programs that support various objectives and recommendations of the plan.
- Coordinating community action where we know change can make a difference to preserve and protect the health of Pigeon Lake and its watershed. i.e. Mulhurst Park, washrooms, and adding a rain garden (Natural green solution to runoff).
- Secretariat to Pigeon Lake Watershed management plan. Looking for solutions, but there is no silver bullet, but do have this plan. Will look into different ideas for solutions, there are processes for reviewing suggested solutions. One issue, Pigeon Lake is very large, so it is difficult to find a solution that works for the whole lake.

- Building capacity. In 2019, 3 staff reached 1500 face-to-face. In 2020, we had to get creative on how to interact with the community. Examples included creating stewardship tools, a new website, factsheets, tip sheets. Creating a stewardship network for camp directors, ALUS...
- New website is being implemented.
- Finding funding and building partnerships to implement the Pigeon Lake
  Watershed Management Plan
- Updating information and creating new stewardship opportunities and website
  - Naturalizing your lot: Lake-Friendly Landscape Guide
  - o Checklist for residential construction to highlight watershed regulations.
  - Website
- Connecting with stakeholders.
  - o Developing a stewardship network with Camp Directors at the Lake
  - Working with Realtor to welcome new residents and cottage owners
- Supporting the Municipalities and working with partners to address policy-based objectives
- Advocating for changes from the provincial government watercraft inspection stations
